In exercise of the powers conferred by Articles 234 and 235 of the Constitution of India, the Governor of Kerala, in consultation with the High Court of Kerala, hereby make the following rules further to amend the Kerala Judicial Service Rules, 1991 issued under G.O.(P)

No.190/91/Home dated 31<sup>st</sup> December, 1991 and published as S.R.O. No. 1621/91 in Kerala Gazette Extraordinary No. 1518 dated 31<sup>st</sup> December, 1991, namely:-

#### **RULES**

1. Short title and commencement .- (1) These rules may be called the Kerala Judicial Service (Ninth Amendment) Rules, 2024.

(2) They shall come into force at once.

2. Amendment of Rules.- In the Kerala Judicial Service Rules, 1991, in rule 10, in clause (c) of sub-rule (1)-, (a) after the first proviso the following proviso shall be inserted, namely:-

"Provided further that the provision in sub - rule (e) of rule 10 of Part - II Kerala State and Subordinate Services Rules, 1958 for raising the upper age limit in the case of Ex-Serviceman shall be applicable to such candidates for appointment to category 2 subject to the condition that the maximum age limit shall not exceed 50 years.";

(b) in the existing second proviso, for the words 'Provided further that' the words 'Provided also that' shall be substituted.

## **Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

The High Court has decided to grant age relaxation for Ex-Serviceman in the Kerala Judicial Service Examination in accordance with the provision contained in clause (e) of rule 10 of Part II Kerala State and Subordinate Services Rules, 1958 subject to the condition that the maximum age limit shall not exceed fifty years.

The notification is intended to achieve the above object.
