Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

Sub-Section (6) of Section 87(6) of the Inland Vessels Act, 2021 (Central Act No. 24 of 2021) provides that the State Government shall appoint courts not inferior to that of a Magistrate of the First Class, for the purpose of conducting trial of any person who is charged of any offence as provided under the said Act or the rules made thereunder.

The State Government in consultation with the High Court of Kerala decided to appoint the Chief Judicial Magistrate Courts mentioned in the Schedule to the notification as the Courts for the trial of any offence under the said Act or the rules made thereunder.

The notification is intended to achieve the above object.
