In exercise of the powers conferred by sub-section (3) of section 48 of The Bharatiya Nagarik Suraksha Sanhita, 2023 (Central Act 46 of 2023), the Government of Kerala hereby make the following rules, namely:-



RULES

1. *Short title and commencement.*- (1) These rules may be called the Kerala Information of Arrested Persons Rules, 2025.

(2) They shall come into force at once.

2. *Definitions.*- (1) In these rules, unless the context otherwise requires,-

(a) "Arrest" means the arrest of the person as defined under section 43 of this Sanhita;

(b) "Form" means the form appended to these rules and shall be used for the purpose of providing information of the arrested person;

(c) "Information" means the intimation to the parents, friends, relatives or such other persons as may be disclosed or nominated by the arrested person;

(d) "Mode of information" means the information given through electronic mode i.e., mobile phone, social media applications (including WhatsApp), SMS, landline phone, e-mail as well as physical mode;

(e) "Register" means an Arrest Information Register maintained in every Police Station regarding information of arrest;

(f) "Sanhita" means the Bharatiya Nagarik Suraksha Sanhita, 2023;

3. *Maintaining of Register.*- (1) A Register shall be maintained in every police station as provided in FORM appended to these Rules.

(2) The register serially numbered shall be issued by the District Police Chief to every police station and District Crime Records Bureau. The pages of the Register shall be numbered continuously and attested by the Sub-Divisional Police Officers at the opening page and the last page. On completion of the Register, the same shall be deposited with the Station House Officer on proper receipt. The request for new Register shall be made to the District Police Chief through Sub-Divisional Police Officer.

(3) The police officer designated as arrest information officer under section 37 of the Act shall be responsible for maintenance of the Register.

4. *Duties of the Arresting officer.*- (1) The police officer or any other person making any arrest under this Sanhita is duty-bound to inform the arrested person of his rights under sub-



section (1) of section 48 as soon as he is brought to the police station.

(2) Every police officer or any other person making any arrest under this Sanhita shall in any mode of information give intimation, regarding such arrest and place as to where the arrested person is being held, to any of this relatives, friends or such other persons as may be disclosed or nominated by the arrested person.

(3) The information of arrest, including complete particulars shall be given to the police officer designated under sub-section (b) of section 37 of the Sanhita of the police station concerned as well as the control room in the District.

(4) The police officer designated under sub-section (b) of section 37 of the Sanhita shall enter the details of the person, who has been informed of the arrest in the Register kept in the police station in the form appended to these rules.

(5) The details of the arrest shall be prominently displayed in any manner including in digital mode in every police station and at the district head quarters.

Explanatory Note

(This does not form part of the notification but is intended to indicate its general purport.)

Sub- section (3) of section 48 of the Bharatiya Nagarik Suraksha Sanhita, 2023 (Central Act 46 of 2023) empowers the State Government to make rules for carrying out the purposes of section 48 of the said Act to maintain details in a book regarding the information of arrest, intimation of arrest to be given to the person as may be disclosed or nominated by the arrested person and the police officer making the arrest. Hence the Government have decided to make rules under sub-section (3) of section 48 of the said Act.

This notification is intended to achieve the above object.
